	You will also be responsible for remitting statutory deductions for the Year-end adjustments to the appropriate government agencies.
2025 Tax Form Production timelines	All adjustments related to 2025 payroll that are submitted after last pay of 2025 are subject to ADP fees.

The First Payroll run of 2026	Adjust salaries for Ministry Personnel on the first payroll of 2026. Recalculate Taxable benefits per new salary for the benefit plan members. Refer to Minimum Salaries & Reimbursements for Ministry Personnel (2026) and 2026 Premiums and Taxable Benefits Calculator for details.
Prior to the First payroll run of 2026	For Pastoral charges with bi-weekly payroll frequency, verify the number of pays for 2026, and advise ADP accordingly if there is any change in number of pays (i.e. from 26 to 27 or vice-versa).
The Canadian Dental Care Plan reporting requirement is mandatory for 2025 tax year reporting cycle and electronic filing.
